# **Balance Sheet Explanation**

Welcome to the August explanatory letter. **Current Term Earnings** are a loss of L\$ 117,879 or US\$ 473.41. This rather large increase in loss will be explained below. **Retained Earnings – Previous Term** is L\$ 3,778,891 and Capital remains unchanged at L\$ 11,297.

# Comparative Income Statement Explanation

For the month of August the **Land Tier Revenue** was L\$ 191,512 or US\$ 769.12. This was nearly a \$300 drop in revenue from the previous month and I will explain why this happened. We didn't have a mass exodus of citizens or a group of citizens not paying their tier. We now collect tier via the Hippo system and we allow our citizens the ability to pay up to 3 months of tier in advance. Many of our citizens have taken advantage of this option which results in the situation this month; a considerable amount of August tier was paid in previous months. This action also occurred in the month of April. Even though all tier information is available in each month's financial statements I will show here the tier revenue for the 16<sup>th</sup> and 17<sup>th</sup> sessions.

December \$1,151.53, January \$1,162.48, February \$1,040.02, March \$1,064.17, April \$871.96, May \$1,230.78, June \$1,039.22, July \$1,061.39, August \$769.12.

When you calculate the average of these 9 months of tier you come up with an average monthly tier of \$1,043.41 which is about \$32.00 short of our monthly tier expense.

**Land Sales Revenue** was L\$ 11,498 or US\$ 46.18. **Total Other Revenue** for the month of August was L\$ 989 or US\$ 3.97. The **Total Revenue** for the CDS for the month of August was L\$ 203,999 or US\$ 819.27.

**Expense** was L\$ 9,452 or US\$ 37.96. Our **Events Expense** for the month of August was L\$ 9,550 or US\$ 38.35. **Events Expense** breakdown is presented here. L\$ 3,000 for the remaining 50% for Thunder Rock Promotions Concerts which was the 4 concerts we held at a total cost of only L\$ 6,000. Next we have L\$ 4,050 for the prize pool for the month of August for the 7Seas Fishing Contest. In the month of August there were 5 Fridays so we held 10 contests. The pot was higher in the beginning of the month because we were still new in the contest circles. From here on in the pots will be L\$ 300 for each contest for a total of L\$600 a week. An additional L\$ 2,500 was paid to Wyvern Dryke who hosts the 7Seas Contest which is L\$ 250 a contest or L\$500 a week. We are averaging 20+ attendees at our weekly contests with almost all of them being non-citizens.

Our Web Hosting Expense remained constant at L\$ 2,820 or US\$ 11.33. Our Advertising/Marketing Expense and our Miscellaneous Expense were a combined total of L\$ 650 or US\$ 2.61. So the Total Expenses for the CDS for the month of August was L\$ 290,147 or US\$ 1,165.25. The difference between Total Revenue and Total Expense is a loss of L\$ 86,148 or US\$ 345.98.
